# CLERY REPORTABLE OFFENSES

---

- **Murder/Non-Negligent Manslaughter**
- **Negligent Manslaughter**
- **Sex Offenses (Rape, Fondling, Incest, Statutory Rape)**
- **Robbery**
- **Aggravated Assault**
- **Burglary**
- **Motor Vehicle Theft**
- **Arson**
  
- **Attempts of any general Clery offenses.**

# BIAS RELATED CRIMES

- Simple Assault
- Larceny-Theft
- Intimidation
- Damage/Destruction/Vandalism

Hate Crime Defined - Motivated **IN WHOLE OR IN PART** by bias against:

- Race
- Religion
- Sexual Orientation
- Gender
- Gender Identity
- Ethnicity
- National Origin
- Disability

---

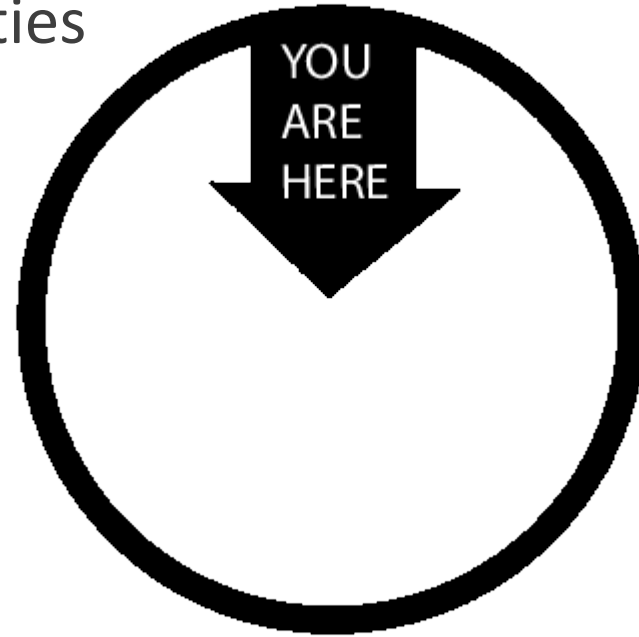
## Arrests and Referrals for certain LAW violations

# Campus Security Authority (CSA)

---

CSA is a Clery Act-specific term

*An official of an institution who has **significant responsibility for student and campus activities**, including, but not limited to, student housing, student discipline and campus judicial proceedings. An official is defined as any person who has the authority and the duty to take action or respond to particular issues on behalf of the institution.*
